### **Correspondence:**

- Trudoxhill have not applied for an LIB budget yet. **Action:** Councillor Cawood to forward details to Mr Lewis for discussion.
- Complaint received that a ditch has been re-dug at the rear of Everleigh resulting in flooding across the footpath onto adjoining land. **No Action**, not a planning matter, complainant advised to contact E.A.
- Cat taken from back of Wyndham and later returned. **No Action.**
- Road sweeper at Trudoxhill. As the mechanical sweeper is unable to clean close to the walls, **Action:** Mr Lewis has requested that a manual sweep is undertaken twice a year.
- Somerset Villa, hedges are growing out into the road. **Action:** Mr D Woodridge (MDC) investigating.
- Resurfacing of Foghamshire Lane, included in initial list for resurfacing. **Action.** CD to ascertain when work will be carried out.
- Street sweeping. **Action:** see above.
- Drain outside Spindletree, now cleared. **No Action.**

- Broiler Sheds at Bunns Lane, Planning Hearing reconvenes at 12:00 on Monday 15<sup>th</sup> September for two days. **Action:** CD to arrange coaches for both days.
- Wessex Incineration. Mr P Twigger has the results of the SPL survey showing that sound levels are above permitted maximum. **Action:** PT to send copies of report to Parish Council and Councillor Cawood.
- Website pictures. Mr Twigger to forward agricultural photographs to Mrs Wallace for inclusion on the website. Mt Drage to do the same with countryside photographs. **Note:** Hospital address incorrect and Mendip is District not County Council.

- Rubble at Nunney Catch. Mr Twigger reported that there is building rubble being unloaded at the first house on the right on the Wanstrow Road. With regard to fly tipping at Gare Hill, this is outside our parish but should be reported to MDC as well.

- Car Park by Village Hall. **Action:** CD to contact Ms Elizabeth Zowers of the Community Council at MDC.
- Speed Signs. Funds allocated but no date for erection. **Action:** CD to chase Ms Beverly Norman at SCC and cc Councillor Cawood.
- Brown Signs. **Action:** Mr G Barry (White Hart) to pass application details to CD and Councillor Cawood for further action.
- Weight Restriction on road through Trudoxhill. **Action:** CD to enquire on SCC website on procedure for applying for restrictions.
- Litter Picking. Mrs Friend not present at the meeting. **Action:** CD to find date of next litter picking and circulate.
